#### **AUSTRALIA CAPITAL TERRITORY**

Within New South Wales is a territory known as the Australian Capital Territory (ACT). This territory was established in 1913, and contains the Australian capital city of Canberra, the Namadgi National Park, and acres upon acres of agricultural land. Canberra is the capital of the federal government of the Commonwealth of Australia, and this area was established for the governance of the country.

#### **NEW SOUTH WALES**

New South Wales (NSW) is one of the states on the eastern side of Australia. Approximately 7.24 million people live in NSW, most of which live and around the capital city of Sydney. There are eleven universities that are located in this region of Australia, including the University of Sydney, which is the largest and most well-known. There are also several universities that are based in other states but have campuses in Australia

#### **QUEENSLAND**

Queensland (Qld) is the second-largest region in all of Australia. There are approximately 4.5 million residents in the state of Queensland, and the population is actually evenly distributed throughout the state. Even though the capital, Brisbane, has the most residents, it only accounts for approximately 45% of the state's population. The University of Queensland and Queensland University of Technology is one of the top 100 universities in the world. There are also a handful of other universities in the state as well.

#### **VICTORIA**

Victoria is in the southeast of Australia. Most of the population (which is approximately 5.3 million) resides in and around the capital, Melbourne. There are eight public universities found in Victoria, including the University of Melbourne and Monash University (the largest university in the country). If you, as an international student, decide to go to Victoria for schooling, you won't be alone – 30% of the state's student population is made up of international students.

#### **WESTERN TERRITORY**

Western Australia is the largest state in Australia, but it has one of the smallest populations. There are approximately 2.4 million people who live in the state, and over 90% of the population lives in the south-western area of the state (near the capital, Perth).

#### THE NORTHERN TERRITORY

The Northern Territory is in the north-central region of Australia. The Northern Territory is the least populated of all of the Australian states and territories with only about 250,000 people living there. The capital of the Northern Territory is the city of Darwin The country only has one university, Charles Darwin University (formerly known as Northern Territory University), which focuses on a variety of higher education and vocational studies.

#### **TASMANIA**

Tasmania is a state made up of the island of Tasmania, directly south of the state of Victoria, and the 334 islands surrounding it. It is recognized as the southernmost point of the country of Australia. The state has a total population of approximately 600,000 and most of them reside in and around Hobart, the capital. There are campuses for other universities found in Tasmania, but the largest public institution in the state is the University of Tasmania, which has 3 campuses throughout the state

#### **SOUTH AUSTRALIA**

South Australia (SA) is in the south central part of Australia. The population is only 1.6 million people (less than 8% of Australia's total). Most of the population resides in and around Adelaide, the capital. South Australia only has three public and three private universities. They also have one vocational school (TAFE South Australia).

Australia is a country that has a very unique history, culture, and geography. There are 6 states and 2 territories in the country of Australia, each of which has their own parliament as well.



### EDUCATION

The costs of studying in Australia depend on the institution and the level of study you choose. There may be additional costs for your course, including course materials and access to institution facilities. The list below gives you an indication of the range of course costs for different types of qualifications. The estimate costs does not include high value courses such as veterinary and medical.

School - \$7,800 to \$30,000 a year

English language studies Around - \$300 to \$500 per week depending on course length

Foundation - \$9,000 to \$14,000 a year

Vocational Education and Training - \$5,500 to \$22,000 a year (Certificates I to IV, Diploma and Advanced Diploma)

Undergraduate Bachelor Degree - \$15,000 to \$33,000\* a year

Postgraduate Masters Degree- \$20,000 to \$37,000\* a year

Doctoral Degree - \$14,000 to \$40,000\* a year

#### Scholarship

They cover various educational sectors, including vocational education and training, student exchanges, undergraduate and postgraduate study and research. Australian Government scholarships are not available for international students undertaking English language training specifically in Australia. However, there are several English language training scholarships offered by Australian institutions. Its very important to apply before the deadline. It includes cover for visits to the doctor, some hospital treatment. ambulance cover and limited pharmaceuticals (medicines). OSHC insurers can provide a range of different OSHC products. These may range from a basic product which covers only the compulsory minimum services to comprehensive products which cover, in addition to the compulsory minimum services, extra services as specified under the particular policy.

#### BANKING

Opening a local bank account is quite simple as long as you do it within six weeks of arriving in Australia. If you do it during that period of time, you need to only show your student ID card and other identifying documentation such as passport or driver license. If you don't have your student ID card ready yet, you may need to bring a proof of enrolment (including your course start and end dates).

Once you open a bank account, you can organise a credit card or debit card (a plastic card that provides you with electronic access to the funds already in your bank account). With a debit card you can organise an electronic funds transfer at point of sale known as EFTPOS. This is the general term used for a debit card and allows you to process transactions through terminal at point of sale. You may use ATMs to make a cash withdrawal or credit card advances.

#### Tax Matters & Work Permits



International students can work 40 hours per fortnight during academic semesters and full-time during University vacations.

You don't need to pay income tax, only Australian resident need to pay. But the employers still deduct tax from our income. But this can be claimed at a later time.

To work, you need to apply for a Tax File Number (TFN). This can be done quite easily online through the Australian government's website.



#### **HOMESTAY**

Homestay is an opportunity to live with an Australian family and experience. Australian culture by participating in the daily routine of the host family's life. Host families assist students to adapt to their new environment. Typically, a homestay includes meals, but students are responsible for the costs of washing, ironing, telephone, internet and transport. International students who are under the age of 18 are required by the Department of Immigration and Border Protection to live in a homestay or stay with a relative who is eligible to be nominated as a carer until they turn 18. Guardians are responsible for the welfare of international students who are in their care.

#### **Independent Rentals**

If you are looking to sign a contract for a rental, make sure that the rental you are looking at is the best option for you. If you have friends that are studying abroad with you or you have friends in the country, you may be able to make the overall price less because of splitting the cost of the rental. Make sure that you get the best deal for your money so that you can stay comfortable while studying in Australia.

Look for a real estate agency or two in the area or city that you are studying in. They may have rentals available for you to check out, and they may be able to work with you on the price and other important factors related to a rental. If you are looking for somewhere to live while studying in Australia, there are a couple of websites that you should definitely check out during the process.



#### **GUARDIANSHIP**

International students who are under the age of 18 are required by the Department of Immigration and Border Protection to live in a homestay or stay with a relative who is eligible to be nominated as a carer until they turn 18. Guardians are responsible for the welfare of international students who are in their care

#### **ON-CAMPUS ACCOMMODATION**

It is ideal if you want to live with other students from the same institution and close to your place of study. These are typically multi-room residences where you are provided with a bedroom with a single bed, desk and chair and storage space. Bathrooms are commonly shared.


